REGULATIONS FOR A LOGO CONTEST

The aim: To select 1 logo from a total of 5 to 10 logos submitted by all partners

Procedure:

- 1. Each partner announces a logo contest at school;
- 2. Each country selects 1-2 logos and sends it until November 11th, 2022;
- 3. The final logo will be decided during the 1st mobility of the project, in Romania;

Requirements for the logo contest:

- 1. A logo must be original and created by a member of each partners organization. The logo shouldn't violate any copyright laws;
- 2. The acronym or the name (ESWM or Everything Starts with Mathematics) of the project must be included in the logo;
- 3. The logo should be simple and colorful;
- 4. The logo must be in JPEG, PNG and/or PDF format;
- 5. A contestant should write the author's name, surname and class in the title of a file;
- 6. The logos are evaluated and chosen as the best by the members of the project. The winner is the one who gets the biggest number of votes.
- 7. The logo should have Erasmus+ Visual Identity (logo).
- 8. The logo should have the reference number of the project.
- 9. The logo should be related to the theme of the project.

Prizes of the contest:

1. The participants and winners of the contest will be considered for participation in future activities with students involved;

Note: this does **not** imply that students will automatically be chosen for participation in the mobilities.

REGULATIONS FOR A POSTER CONTEST

The aim: To select one poster from a total of 15 posters submitted by all partners

Procedure:

- 1. Each partner announces a poster contest at school;
- 2. Each country selects the 3 best posters and sends it until November 11th, 2022;
- 3. The final poster will be decided during the 1st mobility of the project, in Romania;

Requirements for the logo contest:

- 1. The poster must be original and created by a member of each partners organization. The poster shouldn't violate any copyright laws;
- 2. The project title must be included in the poster;
- 3. Partners' flags and the acronym of the project must be included in the poster;
- 4. The poster should be informative, clear and suitable for publications;
- 5. The poster size should be 50 x 70 cm.
- 6. The poster should have the reference number of the project.
- 7. The poster should be related to the theme of the project.
- 8. The poster must be in JPEG, PNG and/or PDF format;
- 9. A contestant should write the author's name, surname and class in the title of a file;
- 10. The posters are evaluated and chosen as the best by the members of the project. The winner is the one who gets the biggest number of votes.

Prizes of the contest:

1. The participants and winners of the contest will be considered for participation in future activities with students involved;

Note: this does **not** imply that students will automatically be chosen for participation in the mobilities.





REGULATIONS SILENT SHORT VIDEO COMPETITION



Aim

• A silent short film about students encountering problems with Maths will be shot by the students of the institutions



Procedures



Each partner announces a short video contest at school;



Each country selects the winner video until 19/05/2023;



Each partner sends the winner video to the coordinator;



The five winner videos will be uploaded on the project website by the coordination;



An international contest will be organized in order to select the winner video which will be publicly announced in the coordinator country – Türkiye.



Requirements

Videos must be original and created by students of each partner organizations;
Videos must not violate any copyright laws*;
The videos shall focus on maths difficulties;
Duration: Between 1 minute (minimum) and 3 (maximum);
The video must be in English. Any subtitles or text included shall also be in English;
The opening of the video must include the logo of the project and its reference number (2021-1-TR01-KA220-SCH-000032799);
The closure of the video must include the disclaimer text (<i>This project has been funded with support from the European Commission. This publication reflects the views only of the author, and the Commission cannot be held responsible for any use which may bemade of the information contained therein.</i>);
The closure of the video must include credits as well as the logo of the partner institutions.



Requirements & further recommendations

Video resolution accepted:

4320p (8K): 7680 x 4320 2160p (4K): 3840 x 2160 1440p (2K): 2560 x 1440 1080p (HD): 1920 x 1080

It is higly recommended avoiding recording people so there's no need for consent forms;

Platforms such as PowToon are free and can be a good way to start;

Considering the present regulations and other internal criteria that might be applied, teachers will decide the winner video from their countries.

What follows?

An international contest will be organized to select the video that will be broadcast by the coordinator on platforms such as YouTube.

Karaman Provincial Directorate of National Education will make necessary initiatives and applications to the Ministry of National Education in order for this film to be a public service announcement.



Deadlines **#**

27th March – 21st April – announcement of the contest in schools;

12th May – deadline for students submitting the videos;

19th May – each partner country selects the winner video in accordance with the present regulations;

22nd - 26th May – partners send the winner video to the coordinator;

31st May – deadline for coordinator to upload the vídeos on the website;

31st May - CEPROF send the Google Form for the international contest + regulations;

16th June – deadline for voting;

23rd June – announcement of the winner; Turkey announcement – Karaman authorities.
